## Eligibility Criteria for Dealership on DODO Model

### A) For Individuals

- (i) Nationality : Should be an Indian National.
- (ii) Age : As on the date of application (in completed years) not less than 21 years.
- (iii) Educational Qualification : Minimum Matriculation or equivalent from recognized board.
- (iv) Financial Strength : Should have minimum financial strength of Rs. 80 Lakhs (Bank Solvency Certificate, Income Tax Return of Last Three Years, Statement of Movable / Immovable Properties required as proof). The amount mentioned here is only for deciding eligibility criteria. The actual funds to be arranged would vary from case to case basis as determined by GGL. The same does not include cost of development of land being offered.

### B) For Others

- (i) Partnerships: In case of partnerships, all partners have to individually fulfil the eligibility criteria as specified above in eligibility criteria for individuals and each partner to fill separate application forms along with separate application fees and club together and submit in single sealed envelope. In respect of partnerships, all partners will have to attend the interview together and they will be evaluated individually for individual parameters like age, educational qualification, etc. The finance owned by any one of the partners will be treated as the same being owned by the firm as a whole for evaluation purposes,
- (ii) Registered Co-op. /Consumer Societies: Societies registered under Societies Registration Act, 1860 / Societies registered under Co- operative Societies Act, 1912 or Co-operative Societies Act as enacted by concerned States, Charitable Trusts registered with Charity Commissioner of respective State Government, Companies formed under the Companies Act, 1956 / 2013 (except Pvt. Ltd. companies), there should be at least one person fulfilling eligibility criteria for individuals, as specified above.
- (iii) In case of a firms/ companies/ organized bodies, there should be at least two persons fulfilling eligibility criteria for individuals, as specified above. Each person should fill separate Application Form along with separate application fees and club together and submit in a single envelope.

### C) Land:

The applicant(s) should be in possession of required size of suitable plot of land in the area defined in Annexure-A of EoI by way of ownership through clear title in his name / his family (spouse/unmarried children) or through lease for a minimum period of 15 years.

OR

The applicant(s) should have a consent from Land Owner(s) in possession and ownership through clear title of required size of suitable plot of land in the area defined in Annexure-A of EoI, to transfer the plot to Applicant through outright sale or lease for a minimum period of 15 years for development

of CNG Station on the plot under DODO model whose Dealership shall be awarded to Applicant by GGL.

**D)** Applicants with the experience in the following field / activities shall be given priority.

- Forecourt management of retail outlets of Petroleum products.
- Working experience in oil and gas sector.
- Retired executives from Defence

**E) Documentary Proofs** fulfilling all the above eligibility criteria shall be submitted by the applicants.

**F) Eligibility to Apply:** Following meeting the above specified eligibility criteria are eligible to apply:

- (i) Any individual / firm / public limited companies.
- (ii) Partnerships: Only the partnership firms making a net profit (PAT) for the previous three consecutive financial years as certified by a chartered accountant will be eligible.
- (iii) Registered Co-op. / Consumer Societies: Only the society making a net profit for the previous three consecutive financial years as certified by a chartered accountant will be eligible.
- (iv) Organized Bodies: Government Bodies/Agencies, Charitable Trusts registered with Charity Commissioner of respective State Government, making a net profit (PAT) for the previous three consecutive financial years as certified by Chartered Accountant will be eligible.
- (v) Private Limited Companies: Making a net profit (PAT) for the previous three consecutive financial years as certified by a chartered accountant will be eligible.

**G) The following are not eligible to apply:**

- (i) Applicants convicted or against whom charges have been framed by a Court of law for any criminal offence involving moral turpitude/economic offence (other than freedom struggle).
- (ii) Mentally unsound person / totally paralyzed person.
- (iii) Signatory to an agreement of RO/SKO-LDO Dealership / LPG Distributorship of any Oil Company terminated on the grounds of adulteration/malpractice wilfully giving wrong information.

**H)** While an entity can apply for different locations (upto a maximum of 4 locations), the same should be done in separate application forms in respect of each location along with applicable application fee in each case. Each application should be complete in all respect and documents attached with one application cannot be considered for other application(s). All the eligibility criteria as specified above shall be applicable in each application. The Criteria for the Financial strength, shall be applicable separately in each case and shall be equal to the no. of locations multiplied by the amount required for one location as per the Criteria.

**I)** A person selected for the dealership shall pay attention towards day to day working of the dealership and manage the affairs of the dealership either personal presence on regular basis or appointing

competent person for said work. If the selected person is already in service / employed somewhere else, he/she will have to resign from the service / employment prior to appointment as dealer

- x) Land Documents:
  - (a) Certified copy of '7 / 12' Extracts or its equivalent viz. Khatoni, Jamabandi, Khasra, Girdawari, etc. and the Title Deed viz. Sale/Lease Deed, etc. showing the ownership of the land.
  - (b) Copy of Ferfar/Mutation Record/Entry.
  - (c) Key plan showing details of the property situation of the plot.
  - (d) Area offered for CNG Station along with dimensions of the plot.
  - (e) Applicable tax, e.g. Property / Municipality / Gram Sabha Tax etc. should have been paid up-to-date to the appropriate authority. Copy of latest Tax paid receipts / challans, shall be furnished.

I further undertake to provide additional documents related to eligibility for Dealership and the land over and above those listed above, if required and asked for by Green Gas Ltd. at any stage viz. during evaluation of offer or for finalising the transfer of plot to Green Gas Ltd. or while awarding the Dealership. I understand that inability to provide any such document may lead to rejection of offer / cancellation of LoI.

- 4) All documents / photocopies of the documents necessary in this connection and as required in GGL Notice are enclosed hereto. GGL is free to reject my/our Application if any of the documents / photocopies of the documents is/are found to be false or forged.
